Dear parents and Carers,

As you may be aware at Campus Kidz breakfast and afterschool club, we have Electronic Week for the children on the last week of every term. The children absolutely love this week, and we enjoy giving them the opportunity to be themselves and do something they would normally enjoy doing at home.

In order for us to continue running Electronic week, we need to ensure that all children are safe and know the rules around technology and internet safety.

We would be grateful if you discussed these rules with your children and sign to say you have done so.

ELECTRONIC WEEK RULES:

- **Children are not allowed to take photos or videos during breakfast and afterschool club on their devices.**
- **All apps and games on devices must be age appropriate (checked by the parent first at home)**
- **Key stage 1 and Key stage 2 children will have different zones, and sharing of devices will not be permitted between zones. (this is because key stage 2 can access games etc that key stage 1 cannot)**
- **Staff will monitor what the children are doing throughout the session to ensure they are not accessing anything they shouldn't be.**
- **Internet will only be accessed with parental permission. (AVPS internet already has parental controls and restrictions on as to what children can access)**
- **Children with their own mobile data will not be allowed to access sites or games that are not appropriate especially around other peers and this must be explained at home.**
- **Devices are kept in a box in the office during the school day and this is where we encourage children to keep them, however children/parents are responsible for their devices, and we cannot accept liability for any damage of lost/stolen goods.**
